 - o Lexi asks, "What are the responsibilities of the point person?"
 - Evan asks, "Is there an expectation that we have a legal guardian?"
 - Ben says, as a coach, that you sign off as a legal guardian.
 - These positions are mandated reporters.
 - Sam says we can craft policies adversarial to this, regarding age ranges.
 - Lexi asks What if we instituted an age minimum?

- o 18?
- o 16?
- o 12?
- o 10?
- No one under 13 without board permission?
- Lexi suggests, "Can we posts preview so that people (not just minors) know the level of difficulty of the music?" It would help people know what they are signing up for.
- Nina suggests We are not expected to teach the children how to play the instrument. The policy should reflect this.
- Evan ponders the two questions we are trying two answer.
 - Rules for the individuals (age minimum, conditions for minors like chaperoning)
 - And how do we support them musically
- Lexi asks...do we require DCF training? Who is required?
- Nina proposes the following plan: The Personnel Committee comes up with some options about different plans to present to the Executive Board.
