#### Stephen motions to discuss the budget for the next fiscal year

Stephen showed off key differences between 2023 and 2024 budgets line by line. Key differences include:

- Rehearsal costs are significantly less than expected for the 2023 fiscal year
- Merchandise was given more funds to spend and a higher expected income
- Donations were budgeted for much more as we have seen increased donation activity
- There were many more smaller changes available in the publicly published budget

Stephen then showed the new 2024 budget implementing the previous changes into the budget format then opened the floor for discussion:

- The board decided to allocate an additional \$100 to the merchandise expenditure to make a full merchandise restock possible
- It was proposed to remove funds from "concert space rentals," but ultimately was left unchanged

Budget was unanimously approved and will be presented at the next general members meetings

Evan moves to discuss the 2024 vision statement

The board discussed the following goals for the 2024 fiscal year:

- Establish relationships with venues that allows for the NGSO to have more periodic concerts, to help us establish distinct and regular seasons.
- Establish relationships with venues that allows for the NGSO to have long-term, formal use agreements for spaces for rehearsals and other activities.
- Refine or rewrite the bylaws, especially around the definition of membership.
- Continue to foster an environment conducive to musical development of the membership.
- Continue to do some online events.
- Continue to refine the responsibilities and compositions of different committees within the orchestra, with focus on reducing individual load for those on multiple committees.
- Improve our onboarding procedures for new members.
- Revise and expand the NGSO's strategy around sources of consistent, reliable income

It was decided that the above goals would be labeled as the NGSO's "strategic plan." Alex volunteered to implement some level of accountability for the group on the plan. It was agreed that these goals could use some refining to make them "measurable."

As a result, Sam will turn the above strategic plan into a short "vision statement" to present to the general membership at the June 19th meeting. This plan will involve themes of "refinement and stabilization"
